We have been asked to provide this due diligence opinion to you with regard to the laws of the United Arab Emirates ("**UAE**") in connection with the listing of the ordinary shares of Softcare ("**Shares**") on the Main Board of The Stock Exchange of Hong Kong Limited ("**Proposed Listing**"). The Proposed Listing will involve an offering for subscription

We have been asked to provide this due diligence opinion in relation to both Senbai Holdings FZCO ("Senbai") and Sunmart Trading FZCO ("Sunmart") (Senbai and Sunmart shall collectively be referred to as the "Companies") which are both incorporated in the Dubai Airport Free Zone ("DAFZ"), Dubai, UAE and licensed by the Dubai Airport Free Zone Authority ("DAFZA").

This due diligence opinion is delivered to the Hong Kong Underwriters pursuant to clause 2.1 of the Hong Kong Underwriting Agreement and to the International Underwriters pursuant to section 7 of the International Underwriting Agreement and would be relied upon by legal counsels and investors designated by Softcare (if applicable).

DOCUMENTS REVIEWED

For the purpose of our due diligence opinion, we have examined the following documents (together, the "Documents"):

- (i) the prospectus dated 31 October 2025 (the "Prospectus") and the offering circular dated 6 November 2025 issued by the Company in relation to the Proposed Listing;
- (ii) copies of the material contracts and all loans and financing arrangements involving the Companies to which a Company is a party or which are binding upon it or any of its assets (the "Material Contracts") as set out in Part 1, Appendix B;
- (iii) copies of the documents referred to in Part 2, Appendix B hereto (together, the "Other Examined Documents");
- (iv) the responses to our due diligence tracker ("Diligence Tracker"); and
- (v) the responses to our due diligence questionnaire ("Questionnaire").

OPINIONS

Based upon our review of the Documents and subject to the assumptions and qualifications set out in Appendix A, we give the following opinions in relation to the matters set out below:

A. Incorporation and Corporate Information

- Both of the Companies have been duly incorporated under the laws of the DAFZA. The Companies are separate legal entities and possess the capacity and authority to sue and be sued in their own name. The Companies are not immune from any laws. Further information of the Companies is set out in Appendix C hereto.
- 2. The memorandum and articles of association, of each of the Companies, are in a standard DAFZA-issued form and are therefore not in breach or violation of any laws or regulations of the DAFZA. We understand that the copies of the memorandum and articles of association of the Companies are the current versions and that such versions have not been amended.

- 3. The memorandum and articles of association, of each of the Companies, are in compliance with and are not in breach or violation of any laws or regulations of the DAFZA. The memorandum and articles of association of each of the Companies are duly adopted and all other constitutive documents of the Companies, that are required to be filed with the DAFZA, have been so filed.
- 4. The Companies have the full corporate power and capacity to own, use, lease or operate their respective properties and assets and carry on their respective, current business under their memorandum and articles of association and the laws of the DAFZA. There are no restrictions under the memorandum and articles of association of the Companies affecting such ability, power and capacity.
- 5. The entire issued share capital of each of the Companies (i) has been duly and validly authorised and issued in accordance with the laws of the DAFZA and the memorandum and articles of association of the relevant Company without contravening any pre-emptive rights, re-sale right, right of first refusal or similar rights under the laws of the DAFZA or the memorandum and articles of association of the Companies, (ii) is free and clear of all charges, security, liens, encumbrances, equities or claims and not subject to any mortgage, charge, pledge or other third party interest, and the shareholder of the Companies (Softcare FM Limited, previously known as Sunda FM Limited) has good and valid title to the shares of each of the Companies. Each such share rank pari passu in all respects with one another.
- 6. There is no legal restriction on foreign ownership (direct or indirect) with respect to either of the Companies.
- 7. There is no dispute relating to the ownership of or title to the shares of either of the Companies.
- 8. There are no outstanding rights, warrants or options to acquire, or instruments convertible into, any shares or equity interest in the Companies.
- 9. Based on the due diligence performed to date, there has not been a change in the shareholding of the Companies, from the date of their incorporations up to the date of this due diligence opinion.
- Since the incorporation of the Companies and up to the date of this due diligence opinion, the identity of the shareholder and the general manager (of each of the Companies) is as set out in Appendix C hereto. The general manager of each of the Companies has been appointed in accordance with the laws of the DAFZA owing to such general manager being named on the license of each Company. All consents, approvals and authorisations of, and all filings, registrations and qualifications with, any court, governmental or regulatory department or agency or other regulatory body in the UAE required under the laws of the UAE with respect to the issuance of shares upon incorporation have been obtained. There is no stamp duty to be paid in respect of such issuance of shares. The shareholders are qualified to be shareholders of each of the Companies under the memorandum and articles of association of each of the Companies and all applicable laws and regulations.
- 11. The Companies have the full power and authority under the laws of the DAFZA and their respective memorandum and articles of association to declare and effect dividend payments/distributions in or out of DAFZA and the UAE freely in any foreign currencies without the necessity of obtaining any UAE governmental approvals or permits. The Companies are not currently prohibited from or are subject to any restrictions in, directly or indirectly, paying any dividends or other distributions to the holders of their respective shares under their memorandum and articles of association and/or under the current laws and regulations of the DAFZA. All dividends are free and clear of withholding or deduction of any tax in the UAE.

- 12. There are no loans that have been provided to the Companies by their shareholder. Sunmart has provided loans to and has obtained loans from group entities. To the best of our knowledge, as at the date of this opinion, Sunmart has receivables of approximately USD 33,000,000 whereas Senbai has receivables of USD 2,000,000. To the best of our knowledge, most of the receivables due to Sunmart are the loans that have been provided by Sunmart to other Group entities (please see Part 1, Appendix B for further details).
- 13. The Companies have not provided any guarantees.

B. Acquisition and Reorganization

14. There has been no change in the shareholding of either of the Companies, from the date of their incorporations up to the date of this due diligence opinion.

C. Legal and Compliance

- Each of Companies has obtained all necessary licenses, consents, authorizations, permissions, declarations, approvals, orders, registrations, clearances, certificates, permits and reports ("Government Authorizations") from and has made all filings with government agencies or body or any other regulators ("Authority") in the DAFZA for it to own, lease, license and use properties (including any planning, building, construction and occupation permits and approvals) and assets, and to conduct its current business in so far as such properties and assets and the conduct of such businesses are governed by the laws of the DAFZA. During the Track Record Period (as defined below) and up to the date of this legal opinion, these Government Authorizations had been and are valid, in full force and effect, and contain no material restrictions or conditions. There are no legal impediments to the renewal of such Government Authorizations, and there are no proceedings pending or threatened relating to the revocation, suspension, withdrawal, cancellation, modification or non-renewal of any such Government Authorizations. Please refer to the headings entitled "Government Authorisations" in Appendix C for details of the relevant Government Authorizations.
- 16. All necessary corporate filings of the Companies have been made on a timely basis in the DAFZA since their incorporations.
- 17. The Companies were in compliance in all material respects with all applicable laws, regulations, rules and their respective memorandum and articles of association during the three years ended 31 December 2024 and the four months ended 30 April 2025 (the "Track Record Period") and thereafter up to the date of this legal opinion.

D. Insolvency and Litigation

- 18. There are no formal insolvency or litigation searches in the UAE. Based on informal court searches against each of the Companies at the Dubai courts, as carried out in July 2025, neither of the Companies has or is currently a party to any form of litigation in the Dubai courts. By way of background, these forms of informal court searches cover both civil and criminal proceedings and are made across all levels of the Dubai courts, those being the court of first instance, the court of appeal and the court of cassation. The results of such searches were provided to us verbally.
- 19. To the best of our knowledge, there is no order, writ of summons, petition or shareholders' resolution filed or passed for the dissolution or liquidation of the Companies or appointment of a receiver, administrator or

liquidator in the UAE in connection with the winding-up, dissolution or carrying out of liquidation procedures in respect of the Companies or their assets.

20. To the best of our knowledge, there is no current investigation or regulatory proceeding by or involving the Company, its directors or senior management.

E. Proposed Listing of Softcare

- 21. No approvals, authorisations or consents will be required and no filings or notifications will need to be made to any Authorities as a result of the Proposed Listing (including but not limited to the issue and sale of Shares under the Global Offering and the associated changes in shareholding and directors of Softcare).
- 22. The consummation or performance of the transactions contemplated by the Proposed Listing (including but not limited to the issue and sale of Shares under the Global Offering and the associated changes in shareholding and directors of Softcare) do not contravene, violate, conflict with or constitute a default under:
 - (a) any law, regulation, judgement, ruling, order or decree of the UAE applicable to the Companies which is currently in force;
 - (b) the Companies' memorandum and articles of association; or
 - (c) any agreement/instrument binding upon the Companies or any of their assets (including the Material Contracts).
- 23. The consummation of the transactions under the Global Offering, including the execution and the delivery of the relevant agreements by Softcare in connection therewith will not violate (i) the Material Contracts and (ii) any judgment, order or decree of any governmental body, agency or court having jurisdiction over the Companies or any of their assets or (iii) any applicable law, regulation or rule of the UAE or the articles of association of each of the Companies.
- 24. Neither of the Companies are a party to any of the relevant underwriting agreements in connection with the Global Offering.

F. Tax

- 25. There is no form of public search on tax filings in the UAE. To the best of our knowledge, no applicable taxes (including corporate tax and transfer pricing tax) are payable by the Companies for the tax years 2022 and 2023. The first tax year of the Companies is 2024, and, with that said, both Companies will have a deadline of 30 September 2025 to make their corporate income tax return filings to the relevant UAE tax authority. Neither of the Companies are registered for value added tax owing to the fact that the business of both Companies does not involve business within the UAE.
- 26. To the best of our knowledge, there are no tax waivers, relief, concession and preferential treatment granted to the Companies.
- 27. To the best of our knowledge and based on a confirmation provided by the Companies, the Companies have complied with all the applicable laws of the UAE on tax matters and they have not been subject to any

- penalties, fines, investigation, dispute or other administrative sanctions for violation of any applicable law applicable laws of the UAE during the Track Record Period and up to the date of this legal opinion.
- 28. There are no restrictions (including any requirement for approval, licence or filing) on the repatriation of profits of the Companies or foreign exchange controls affecting the Companies under the current laws and regulations of the DAFZA or the UAE.
- 29. Senbai has not incurred any transfer pricing issues since its incorporation. During the Track Record Period, there is no transfer pricing tax liability of Sunmart which would give rise to or result in any material adverse effect on Sunmart, and the transfer pricing documentation of Sunmart is compliant with applicable laws and regulations of the DAFZA and the UAE.

G. Assets and Intellectual Properties

- 30. Senbai does not hold any form of intellectual property.
- 31. Sunmart has duly registered and is the owner of various intellectual property, in the form of trademarks, patents and copyrights, across various jurisdictions all over the world. To the best of our knowledge, all such intellectual properties are registered in the name of Sunmart, remain valid and effective as of the date hereof and are free of any outstanding mortgages, charges or other kinds of security granted over or registered against them. Details of all intellectual property held by Sunmart are set out in Appendix D.

H. Loans, Financing Agreements and Material Contracts¹

- 32. The Material Contracts, as entered into by Sunmart, were duly entered into. Sunmart has the power and legal capacity to enter into and perform their obligations under the Material Contracts, to which Sunmart is a party, and the execution and performance of its obligations under the Material Contracts, to which Sunmart is a party, will not contravene its memorandum and articles of association. Sunmart has taken all necessary corporate actions to authorise the execution, delivery and performance of the Material Contracts to which Sunmart is a party. The obligations of Sunmart under the Material Contracts to which it is party constitute legal, valid, binding and enforceable obligations of Sunmart. No Government Authorizations are required for the execution, delivery and performance of the Material Contracts.
- 33. Sunmart is not in default of any of its respective material obligations or covenants under the Material Contracts to which it is a party. To the best of our knowledge, there is no breach of the Material Contracts and Sunmart has not received any notice from any counterparties relating to any breach or default of the Material Contracts.

¹ "Material Contracts" shall at least include any contract that:

⁽a) involves a significant sum of money (e.g. not less than threshold to be set depending on the circumstances, e.g. USD500,000);

⁽b) is important to the overall business of the Company (e.g. any agreement in relation to any important distributorship, major suppliers, customers or manufacturers of the Company);

⁽c) the Company must rely on for its operations (e.g. any agreement between any member of the Issuer group and any e-commerce platform or sales channel in the relevant jurisdiction, agreement in relation to licence of intellectual property right);

⁽d) contains any restrictive provisions in respect of the financing, listing or other fund-raising activities of the Company and/or its shareholders; or

⁽e) contract or agreement that is not in the ordinary course of business of the Company, including any contract or agreement with connected persons or parties, finance/guarantee agreements or documents.

I. Real Properties and Leases

- 34. Appendix E sets out the real properties leased by the Companies. The leases are legal and duly executed. The Companies comply with the usage of these properties. The Companies do not own any real properties.
- 35. There are no defects, liens, claims, restrictions, encumbrances or outstanding security (e.g. mortgage) over any real property leased by the Companies.
- 36. By way of background, all companies licensed by the DAFZA are required to lease premises within the area of the DAFZ. This explains why the Companies have each leased at least one property within area of the DAFZ (such leases are registered with the DAFZA). We note however that only one of these leases, as leased by Sunmart, has been registered with the relevant lease registration department of the Dubai Land Department. This is due to the fact that such premises is based in the mainland of the UAE (i.e. in the non-free zone area (including the DAFZ) of the UAE).

J. Labour

- 37. Appendix F provides a summary of the employment terms for each of the employees currently employed by Sunmart. Senbai does not have employees.
- 38. There has not been any dispute, disturbance or other conflict between Sunmart and any of its employees.
- 39. Based on the due diligence performed so far and a confirmation provided by the Companies, Sunmart has complied with all applicable employment and labour laws and regulations during the Track Record Period and up to the date of this legal opinion. There are no employee retirement fund schemes for employees of Sunmart and the absence of any such schemes is not in contravention of the applicable laws of the DAFZA.
- 40. The form and content of the sample employment contracts, concerning certain employees of Sunmart, are in compliance with the applicable laws of the DAFZA. All of its employees have gone through proper recruitment processes.

K. Insurance

41. Sunmart is required to maintain and has duly provided its employees with health insurance coverage according to applicable laws of Dubai. We have reviewed an insurance policy that Sunmart has procured from a health insurance provider named April Insurance PJSC. The relevant coverage period is from 17 September 2024 to 16 September 2025. Save as to the aforementioned, Sunmart is not required to maintain any other insurance policies for its business in accordance with the laws and regulations of DAFZA.

L. Environmental

42. The Companies have complied with the environmental protection laws and regulations of DAFZA and have not been penalised for violation of laws and regulations on environmental protection.

M. Anti-money Laundering / Anti-Bribery / Foreign Exchange / OFAC and Other Compliance

- 43. Based on due diligence performed so far, including our enquiries made of the Companies and the litigation searches in respect of the Companies conducted at the Dubai courts, during the Track Record Opinion and up to the date of this legal opinion, the Companies have complied with the following laws and regulations and no adverse finding in relation to such matters has been identified: all applicable anti-money laundering laws, anti-corruption and anti-bribery laws, foreign exchange-related laws, OFAC, U.S. and other international sanction laws and regulations.
- 44. Based on due diligence performed so far, including our enquiries made of the Companies and the litigation searches in respect of the Companies conducted at the Dubai courts, during the Track Record Period and up to the date of this legal opinion, the Companies have complied with the following laws and regulations and no adverse filing in relation to such matters has been identified: (i) personal data and data protection laws and regulations; (ii) competition and anti-trust laws and regulations; (iii) product liability laws and regulations; and (iv) import/export-related laws and regulations (including but not limited to import and export control and import and export custom clearance procedures).

N. Prospectus

- 45. The statements set forth in the Prospectus, in so far as such statements summarize or describe the laws, statutes, rules and regulations of DAFZA and the UAE, fairly and accurately summarise or describe such laws, statutes, rules and regulations of DAFZA and the UAE.
- 46. The statements which are set out in the Prospectus regarding each of the Companies and its business, are true, accurate, complete and not misleading.

We hereby confirm our agreement to the inclusion of those statements in the Prospectus that are attributed to us as statements of our "views", "opinions", "advice", or other words of similar meaning. Such statements, and any statements of opinions or views provided by us for inclusion in written responses from you to the Securities and Futures Commission of Hong Kong ("SFC") or Stock Exchange or any other statutory or regulatory authorities are hereby incorporated into this letter by reference, and we hereby agree that you may rely on such opinions as if fully set forth herein.

We have no objection to, if necessary, the inclusion of this opinion or excerpts from this opinion in the Prospectus and its submission to the governmental and/or regulatory agencies, including but not limited to the SFC, SEHK and any other statutory or regulatory authorities.

This opinion may be relied upon by any party, including the CICC, CITICS, CLSA, GF Capital, GF Brokerage and other underwriters appointed by Softcare, their respective affiliates and their respective legal counsels for the Global Offering and their related due diligence, and also the legal counsel appointed by Softcare in connection with the Global Offering (subject always to Appendix A).

- 2.1 Our review has been strictly limited to the Documents. Where reference is made in this due diligence opinion to any document other than the Documents, we have not conducted a review of such document and any reference to such document is made in the context of our review.
- 2.2 We have reviewed the Documents from the perspective of legal liability and legal risk only.

3. Terms of Review

- 3.1 Our review and this due diligence opinion are made subject to the following qualifications:
 - (a) we have undertaken our review on the basis of the Sunmart's instructions only and from your perspective in connection with the Proposed Listing;
 - (b) this due diligence opinion is not intended to act as a recommendation as to whether Softcare should proceed with the Proposed Listing;
 - (c) this due diligence opinion does not replace the representations, warranties and other protections that should be received by Sunmart in any transaction documents relating to the Proposed Listing;
 - (d) our review is based primarily on the Documents;
 - (e) the Documents may not comprise all information that ought to have been supplied to us for the purpose of our review and may not contain all the information relevant to Softcare's decision on whether or not to proceed with the Proposed Listing;
 - (f) we have not made any assessment of the possible commercial or financial consequences of any Document;
 - (g) we have not reviewed documents relating to and express no opinion on accounting, financial, commercial, insurance, tax or technical matters;
 - (h) we have not carried out a formal physical inspection of any premises of the Companies and we have not given any opinion or advice on the valuation, state or condition of any such premises;

- (i) the terms of any Document we have reviewed may have been amended, subsequent to its execution or implementation, orally by the parties, by conduct or by a course of dealing without our being aware of this:
- (j) insolvency and litigation searches carried out for the purposes of the opinion in part D (Insolvency and Litigation) are informal in nature and may not be accurate or up-to-date;
- (k) where our due diligence opinion covers information from Documents containing confidentiality undertakings with third parties, a breach of those undertakings may entitle the third parties to terminate the relevant agreement and/or claim damages for breach;
- (I) please note that, as a UAE law firm, we may not, and shall not be deemed to, express any opinion concerning any law other than the laws of the UAE in force at the date hereof. We are not authorised to provide legal advice on the laws of any other country. As regards any Document governed by the laws of any jurisdiction other than the UAE, we have reviewed such Document on a "common sense" basis only; and
- (m) in all cases, our review takes into account the laws in force in the UAE and as applied by the UAE courts on the date of this due diligence opinion. UAE law is not, in our view, capable of conclusive interpretation, as there is no system of binding precedent in the UAE and a court is not required to follow decisions of another court (although previous judgments can be viewed as persuasive). Case reporting is also not comprehensive, and judgments are not always publicly available. In addition, legislation may come into effect in the UAE without being made publicly available. Similarly, UAE authorities have wide discretion to adopt their own unwritten policies and practices. While we have prepared this due diligence opinion to the best of our knowledge and understanding of the Documents and the relevant laws, practices and publicly available information, these factors may impact the conclusions and recommendations that we have reached.
- 3.2 In conducting our review, we have assumed that:
 - (a) copies of the Documents are true and complete copies of the originals and that the originals are authentic and complete:
 - (b) all signatures appearing on the Documents are authentic;
 - (c) the parties to the Documents had the requisite power to enter into such Documents and perform their obligations under such Documents;
 - (d) the Documents have been executed correctly and are legally enforceable in accordance with the laws of the relevant jurisdiction;
 - (e) each Document is in full force and effect and, except where expressly brought to our attention, has not been terminated or amended and no party to any of the Documents has breached or threatened to breach any of the terms of any Documents;
 - (f) we have been provided with information which was accurate, complete and not misleading when supplied and continues to be so; and
