RE: LEGAL OPINION IN RESPECT OF SOFTCARE (U) LIMITED ("SOFTCARE UGANDA") AND SOFTCARE IMPEX LIMITED ("SOFTCARE IMPEX")

We have been requested to provide this legal opinion to you with regard to the laws of Uganda in connection with the listing of the ordinary shares of Softcare (the "Shares") on the Main Board of The Stock Exchange of Hong Kong Limited (the "Proposed Listing"). The Proposed Listing will involve an offering for subscription to the public in Hong Kong and an international placing of new Shares (the "Initial Public Offering"), subject to the exercise of an over-allotment option to be granted by Softcare for the issue and allotment of additional new Shares up to 15% of offer size of the Initial Public Offering (the "Over-allotment Shares") (together referred to as the "Global Offering"). We have been requested to provide this legal opinion in relation to Softcare (U) Limited and Softcare Impex Limited (together, the "Companies") which are incorporated in Uganda.

This opinion is delivered to the Hong Kong Underwriters pursuant to clause 2.1 of the Hong Kong Underwriting Agreement and to the International Underwriters pursuant to section 7 of the International Underwriting Agreement and may be relied upon by legal counsels and investors designated by Softcare.

DOCUMENTS REVIEWED

For the purpose of our opinion, we have examined the following documents (together, the "Documents"):

- a) the prospectus dated 31 October 2025 (the "**Prospectus**") and the offering circular dated 6 November 2025 issued by the Companies in relation to the Proposed Listing;
- b) copies of the material contracts and all loans and financing arrangements involving the Companies to which the Companies are a party or which are binding upon the Companies or any of the Companies' assets (the "Material Contracts") as set out in Appendix G; and
- c) copies of the documents referred to in Appendix D hereto (together, the "Other Examined Documents").

OPINIONS

Based upon our review of the Documents and subject to the assumptions set out in Appendix A and subject to the qualifications set out in Appendix B, we give the following opinions in relation to the matters set out below:

A. Incorporation and Corporate Information

- The Companies are duly incorporated, validly existing and in good standing under the laws of Uganda.
 The Companies are separate legal entities and possess the capacity and authority to sue and be sued in their own names. The Companies are not entitled to immunity under the relevant laws of Uganda.

 Further information of the Companies is set out in Appendix E hereto.
- 2. The memorandums and articles of association of the Companies are not in breach or violation of any laws or regulations of Uganda and are in full force and effect.
- 3. The articles of association or other constitutional documents of the Companies are duly adopted, and all constitutive documents that are required to be filed with the authority have been so filed.
- 4. The Companies have the full corporate power and capacity to own, use, lease or operate their properties and assets and carry on their current business under their memorandums and articles of association and the laws of Uganda. There are no restrictions under the Companies' memorandums and articles of association affecting such ability, power and capacity.
- 5. The entire issued share capital of the Companies (i) has been duly and validly authorised and issued and are fully paid and non-assessable in accordance with the laws of Uganda and the memorandums and articles of the Companies without contravening any pre-emptive rights, re-sale



right, right of first refusal or similar rights under the laws of Uganda or the memorandums and articles of the Companies, (ii) are free and clear of all charges, security, liens, encumbrances, equities or claims and not subject to any mortgage, charge, pledge or other third party interest, and the shareholders of the Companies have good and valid title to the shares. Each such share rank pari passu in all respects with one another.

- 6. There is no legal restriction on foreign ownership whether direct or indirect under the laws of Uganda.
- 7. The ownership/title of the shares of the Companies is not dispute.
- 8. There are not any outstanding rights, warrants or options to acquire, or instruments convertible into, any shares or equity interest in the Companies.
- 9. Since the incorporation of the Companies and up to the date of this opinion, the identity of the shareholders of and their respective shareholding in the Companies (including all changes within such period) are as set out in Appendix E hereto.
 - (i) Each historical change of the shareholding structure (including but not limited to issuance of new shares and transfer of shares) of the Companies was lawful and valid;
 - (ii) All consents, approvals and authorisations of, and all filings, registrations and qualifications with, any court, governmental or regulatory department or agency or other regulatory body in Uganda required under the laws of Uganda with respect to the issuance or transfer of the shares in the Companies were obtained;
 - (iii) the stamp duty in respect of all issuance and transfer of shares in the Companies was duly paid;
 - (iv) the shareholders are qualified to be the shareholders of the Companies under the memorandums and articles of association of the Companies and all applicable laws and regulations;
 - (v) the historical transfer of shares in the Companies were duly completed, and the transferred shares were properly registered and all relevant taxes were properly paid and were not in violation of any mandatory requirements under the laws of Uganda or the memorandums and articles of association of the Companies.
- 10. Since the incorporation of the Companies and up to the date of this opinion, the identity of the directors and officers of and their respective term of office are as set out in Appendix E hereto. The directors of the Companies were appointed in accordance with the laws of Uganda and the memorandums and articles of association of the Companies.
- 11. The Companies have the full power and authority under the laws of Uganda and their memorandums and articles of association to declare and effect dividend payments/distributions in or out of Uganda freely in any foreign currencies without the necessity of obtaining any governmental approvals or permits. None of the Companies are currently prohibited from or is subject to any restrictions in, directly or indirectly, paying any dividends or other distributions to the holders of their respective shares under the Companies' memorandums and articles of association and the current laws and regulations of Uganda. All dividends paid to either the resident and/or non-resident shareholders are subject to withholding tax at the rate of 15%. A reduced rate, as confirmed under the tax treaty is applicable where the beneficial owner of the dividend is a tax resident in a treaty partner state with Uganda.
- 12. There are no governmental or regulatory approvals required for shareholders' loans. As of the date of this legal opinion, save for an outstanding interparty related loan of USD 1,800,000 (United States Dollars One Million Eight Hundred Thousand only) from Sunmart Trading FZCO, Softcare Uganda has



no outstanding loans, debts and liabilities. Softcare Impex does not have any outstanding loans, debts and liabilities.

13. The Companies have not provided any guarantees.

B. Acquisition and Reorganization

- 14. On 2 May 2024, Century Industrial Limited transferred its 99% equity interest in Softcare Uganda to Sunda FM Holdings Ltd and the other 1% equity interest to Senbai Holdings FZCO. The share transfer by Century Industrial Limited in Softcare Uganda was duly authorized by Softcare Uganda and the share transfer forms were duly executed and are enforceable in accordance with the laws of Uganda. The share transfers in Softcare Uganda do not violate any applicable laws, regulations and the memorandum and articles of association of Softcare Uganda. The share transfers were properly and legally completed.
- 15. On 2 May 2024, Century Industrial Limited transferred its 99% equity interest in Softcare Impex to Sunda FM Holdings Ltd and Kewor Limited transferred its 1% equity interest in Softcare Impex to Senbai Holdings FZCO. The share transfers by Century Industrial Limited and Kewor Limited in Softcare Impex were duly authorized by Softcare Impex and the share transfer forms were duly executed and are enforceable in accordance with the laws of Uganda. The share transfers in Softcare Impex do not violate any applicable laws, regulations of Uganda and the memorandum and articles of association of Softcare Impex. The share transfers were properly and legally completed.
- There was a rearrangement of Softcare's business in Uganda in August 2022 (the "Rearrangement"), where Softcare stopped entering into purchase orders with customers under the fast-moving consumer goods business of Best Ceramics Uganda Limited ("Best Ceramics"). Customers were directed to sign new purchase agreements with Softcare Impex which carries on the fast-moving consumer goods business of Best Ceramics. In connection with the Rearrangement and on the basis that Best Ceramics and Softcare Impex each assume a separate legal personality, Softcare Impex will not assume any residual liability of Best Ceramics for the debt, liabilities and other tax implications as a result of such change under Ugandan laws.
- 17. In respect of the reorganization stated at paragraphs 14 to 16 above, during the Track Record Period:
 - (i) all requisite filings or registrations under laws and regulations of Uganda have been made;
 - (ii) the necessary regulatory approvals, permits and licenses required for reorganization have been obtained from the applicable government authorities and the reorganization complies with laws and regulations of Uganda; and
 - (iii) no agreements or arrangements with third parties necessary for the execution and performance of the transactions related to the reorganization will contravene laws and regulations of Uganda.
- 18. The statements set forth in the Prospectus in respect of the reorganization accurately summarise the reorganization stated at paragraphs 14 to 16 above.

C. Legal and Compliance

19. The Companies have obtained all necessary licenses, consents, authorizations, permissions, declarations, approvals, orders, registrations, clearances, certificates, permits, report ("Government Authorizations") to and filings with government agencies or body or any other regulator ("Authority") in Uganda for them to own, lease, license and use properties (including any planning, building, construction and occupation permits and approvals) and assets, and to conduct its current business in so far as such properties and assets and the conduct of such businesses are governed by Ugandan Laws. During the Track Record Period and up to the date of this legal opinion, these Government



Authorizations had been and are valid, in full force and effect, and contain no material restrictions or conditions. Please refer to Appendix F for details of the relevant Government Authorizations. There are no known legal impediments to the renewal of such Government Authorizations, and there are no proceedings pending or threatened relating to the revocation, suspension, withdrawal, cancellation, modification or non-renewal of any such Government Authorizations.

- 20. There are no Government Authorizations required in Uganda by the Companies that have not been obtained, or any other filing, recording or registration with any regulatory authority or governmental agency in Uganda that has not been effected in connection with the Companies' operations and the Proposed Listing (including but not limited to the issue and sale of Shares under the Global Offering and the associated changes in shareholding and directors of Softcare and/or the Companies).
- 21. All necessary corporate filings of the Companies have been made on a timely basis in Uganda since their incorporation and thereafter up to the date hereof.
- 22. The Companies are compliant in all material respects with all applicable laws, regulations, rules and their memorandums and articles of association during the three years ended 31 December 2024 and the four months ended 30 April 2025 (the "**Track Record Period**") and thereafter up to the date of this legal opinion.

D. Insolvency and Litigation

- 23. Based solely on the searches conducted at the High Court of Uganda and the Uganda Registration Services Bureau/Companies Registry on 16 July 2025 and 14 July 2025
 - i. there is no order, writ of summons, petition or shareholders' resolution filed or passed for the dissolution or liquidation of the Companies or appointment of a receiver, administrator or liquidator in Uganda in connection with the winding-up, dissolution, liquidation procedures of the Companies or their assets.
 - ii. there is no litigation, arbitration, investigation by governmental authorities, administrative proceedings, judicial proceedings, bankruptcy, winding-up, dissolution or liquidation proceedings, prosecution, judgments, fines, penalties, arbitral, disciplinary proceeding or other dispute resolution processes or administrative sanctions involving the Companies or their directors and senior management.
- 24. Based solely on the searches conducted and enquiries made at the Uganda Registration Services Bureau and the High Court of Uganda, there is no current investigation or regulatory proceeding by or involving the Companies, their directors or senior management.

E. Proposed Listing of Softcare

- 25. As of the date hereof, no approvals, authorisations or consents of and from, or filings with or notifications to any Authorities for or as a result of the Proposed Listing (including but not limited to the issue and sale of Shares under the Global Offering and the associated changes in shareholding and directors of Softcare and/or the Companies).
- 26. The consummation or performance of the transactions contemplated by the Proposed Listing (including but not limited to the issue and sale of Shares under the Global Offering and the associated changes in shareholding and directors of Softcare and/or the Companies) do not contravene, violate, conflict with or constitute a default under:
 - any law, regulation, judgement, ruling, order or decree of Uganda applicable to the Companies which is currently in force;



- ii. the Companies' memorandums and articles of association; or
- iii. any agreement/instrument binding upon the Companies or any of their assets (including the Material Contracts).
- 27. The consummation of the transactions under the Global Offering, including the execution and delivery of the relevant agreements by Softcare in connection therewith will not violate (i) the Material Contracts and (ii) any judgment, order or decree of any governmental body, agency or court having jurisdiction over the Companies or any of its assets or (ii) any applicable law, regulation or rule of Uganda or the Articles of Association of the Companies.

F. Tax

- 28. There is no public search on tax filings available in Uganda. The Companies have registered with Uganda Revenue Authority for the applicable taxes including pay as you earn (PAYE) tax, income tax, stamp duty, withholding tax, imports and exports, corporate income tax, and Value Added Tax (VAT).
- 29. All tax waivers, relief, concession and preferential treatment granted to the Companies in Uganda as indicated in a letter from the Uganda Revenue Authority dated 14th April 2023 are valid, binding and enforceable subject to the fulfilment of all the conditions stated therein.
- 30. We have been provided with the following tax clearance certificates issued by Uganda Revenue Authority pursuant to Section 50 of the Tax Procedures Act; tax clearance certificates for the period from 01 July 2021 to 30 June 2022, for the period from 01 July 2022 to 31 December 2022, for the period from 01 January 2023 to 31 December 2024 and for the period from 01 January 2025 and 31 December 2025 in respect to Softcare Uganda, tax clearance certificates for the period from 01 January 2023 to 31 December 2023 for the period from 01 January 2024 to 31 December 2024 and for the period from 01 January 2025 and 31 December 2025 in respect of Softcare Impex showing that the Companies have complied with all their tax obligations in Uganda.
- 31. Based solely on the tax clearance certificates reviewed, the litigation searches referred to at paragraph 23 above and the relevant documents we examined in Appendix D, the Companies have complied with the applicable laws of Uganda on taxation and are not subject to any penalties, fines, investigation, dispute or other administrative sanctions for violation of any applicable law applicable laws of Uganda on taxation during the Track Record Period and up to the date of this legal opinion.
- 32. There are no restrictions, authorizations, consents, licenses, orders, actions, foreign exchange controls/approvals or other government approvals and no filings or registrations with any Ugandan court or governmental authority are required by the Companies on the repatriation of profits of the Companies.

G. Assets and Intellectual Properties

33. Softcare Uganda and Softcare Impex have obtained the necessary licenses and authorizations from the beneficial owners of the intellectual property rights including but not limited to trademarks and industrial designs (the "Intellectual Property Rights") for its use in business operation in Uganda as set out in Appendix D to this legal opinion.



H. Material Contracts

- 34. All the Material Contracts were duly entered into. The Companies have the power and legal capacity to enter into and perform their obligations under the Material Contracts to which they are party and the execution and performance of their obligations under the Material Contracts to which they are party will not contravene their memorandums and articles of association and Ugandan laws and regulations. The Companies have taken all necessary corporate actions to authorise the execution, delivery and performance of the Material Contracts to which they are a party. The obligations of the Companies under the Material Contracts to which they are party constitute legal, valid, binding and enforceable obligations of such Companies. No Government Authorizations is required for the execution, delivery and performance of the Material Contracts.
- 35. The Companies are not in default of any of its material obligation or covenants under the Material Contracts. There has been no breach of the Material Contracts and the Companies have not received any notice from any counterparties relating to any breach or default of the Material Contracts.

I. Real Properties and Leases

- 36. Softcare Uganda has good and marketable title to its real properties and solely and legally owns the real properties described in Appendix H and there are not any defects, liens, claims, restrictions, encumbrances or outstanding security (e.g. mortgage) over any real property owned and/or leased by Softcare Uganda described in Appendix H. The leases are still valid and running. The obligations of Softcare Uganda under the Leases constitute legal, valid, binding and enforceable obligations of the company.
- 37. Softcare Impex does not own any real properties in Uganda. The leases are still valid and running. The obligations of Softcare Impex under the Leases constitute legal, valid, binding and enforceable obligations of the company.
- 38. Softcare Uganda has made all necessary registrations required to make each of its real properties and leased properties legal, valid, binding and enforceable under the laws of Uganda.
- 39. Softcare Impex has made all necessary registrations required to make each of its leased properties legal, valid, binding and enforceable under the laws of Uganda.
- 40. The Companies have taken all necessary corporate actions to authorise the execution, delivery and performance of the tenancy agreement and lease agreements to which they are a party.

J. Production Facility

41. Softcare Uganda plans to build a new production plant in Uganda and build production lines in such production plant for manufacturing baby diapers, baby pants, sanitary pads and/or wet wipes. The regulatory approvals required for such expansion plan include the following:

⁽a) involves a significant sum of money (e.g. not less than threshold to be set depending on the circumstances, e.g. USD500,000);

⁽b) is important to the overall business of the Company (e.g. any agreement in relation to any important distributorship, major suppliers, customers or manufacturers of the Company);

⁽c) the Company must rely on for its operations (e.g. any agreement between any member of the Issuer group and any e-commerce platform or sales channel in the relevant jurisdiction, agreement in relation to licence of intellectual property right);

⁽d) contains any restrictive provisions in respect of the financing, listing or other fund-raising activities of the Company and/or its shareholders; or

⁽e) contract or agreement that is not in the ordinary course of business of the Company, including any contract or agreement with connected persons or parties, finance/guarantee agreements or documents.



- i. Certificate of Approval of Environmental Impact Assessment issued by the National Environment Management Authority under the National Environment Act Cap 181;
- ii. development permit issued by the physical planning committee of relevant local government under the Physical Planning Act Cap 142;
- iii. Building Permit issued by the Building Committee of the area under the Building Control Act, Cap 136; and
- iv. Full operation permit issued by the Kampala Capital City Authority Building Committee to Softcare Uganda for Plot 3 Wankulukuku Road Rubaga Division Kampala.

There is no legal impediment for Softcare Uganda to obtain the abovementioned regulatory approvals for such expansion plan.

K. Labour

- 42. Information relating to the Companies' number of employees and form of employment of employees is provided for in Appendix I.
- 43. There are no ongoing disputes, labour claims, disturbances or other conflicts between the employees and the Companies.
- 44. Based on the relevant documents set out in Appendix D, the Companies are compliant with all applicable employment and labour laws and regulations and all applicable employees' retirement fund schemes during the Track Record Period and up to the date of this legal opinion. Based on physical litigation searches conducted at the High Court of Uganda in respect of the Companies on 16 July 2025, there are no civil or criminal proceedings by or against the Companies recorded in respect of these employment or labour-related matters.
- 45. The form and content of the sample employment contracts provided by the Companies are in compliance with the applicable laws of Uganda. The employees of the Companies have gone through proper recruitment processes.
- 46. The Companies have engaged labour service providers which provide workers to work for the Companies based on the Companies' requirements ("Labour Service Arrangement"). The Companies do not enter into any employment contract directly with the relevant workers. The contracts for the Labour Service Arrangement entered into by the Companies are set out in Appendix D to this legal opinion. The Labour Service Arrangement had complied with the applicable laws and regulations in Uganda in all material respects during the Track Record Period and up to the date of this opinion.
- 47. The Companies have complied with all applicable labour laws and regulations in all material respects during the Track Record Period and up to the date of this legal opinion.

L. Insurance

48. The Companies have duly maintained insurance policies for their business according to the applicable laws of Uganda.

M. Environmental

49. The Companies are compliant with the environmental protection laws and regulations of Uganda and have not been penalised for any violation of laws and regulations on environmental protection.



N. Anti-money Laundering / Anti-Bribery / OFAC / Foreign Exchange and Other Compliance

- 50. Based on our review of the relevant document(s) set out in Appendix D, the Companies are compliant with the following laws and regulations and no adverse finding in relation to such matters has been identified: (i) all applicable anti-money laundering laws, anti-corruption, anti-bribery laws and foreign exchange-related laws of Uganda; (ii) personal data and data protection laws and regulations; (iii) competition and anti-trust laws and regulations; and (iv) product liability laws and regulations since incorporation and thereafter up to the date of this legal opinion. We have conducted physical litigation searches at the High Court of Uganda in respect of the Companies on 16 July 2025, there are no civil or criminal proceedings by or against the Companies recorded in respect of these matters. Based solely on the searches at the Tax Appeals Tribunal (TAT), without prejudice to the right of Uganda Revenue Authority stated at paragraph 50.2 below, there were no pending tax disputes at the TAT in relation to the Companies' compliance with import/export-related laws and regulations (including but not limited to import and export control and import and export custom clearance procedures) as at the date of this legal opinion.
- 51. Based on our review of the tax registration certificates set out in Appendix J, the Companies are duly registered for import and export tax purposes. In accordance with the East African Community Customs Management Act 2004 (as amended) as well as customs clearance procedures set out by Uganda Revenue Authority, for each import/export consignment, the Companies are obliged to submit, among others, the customs declaration forms and commercial invoices. The format of the customs declaration forms is prescribed by the East African Community Customs Management Regulations, 2010 and the forms can be accessed via the Uganda Revenue Authority website. We have been provided with samples of imports customs declaration forms, exports customs declaration forms and commercial invoices as set out in Appendix J. The format of the provided sample customs declaration forms and electronic invoices for export purpose is consistent with the prescribed format set out in the East African Community Customs Management Regulations, 2010 and the Uganda Revenue Authority website.
- 52. In respect of each import/export consignment, upon the importer/exporter providing the required customs documents (including the customs declaration forms and commercial invoices) and payment of the assessed taxes, the Uganda Revenue Authority may make a determination in respect of each consignment that the import/export's requirements have been met and may release the goods to the company. That notwithstanding, Uganda Revenue Authority is empowered under Section 135 of the East African Community Customs Management Act 2004 (as amended) to conduct a post import/export audit in respect of any import/export consignment previously released for a period of up to 5 (five) years.

O. Third-Party Payment

- 53. The third-party payment arrangement, pursuant to which the Companies have received payments from a third party other than its customer to settle the purchase price of products on the customer's behalf ("Third-party Payment Arrangement"), is valid and legally binding and is not in breach of any laws and regulations of Uganda (including anti-money laundering, bribery and tax laws) and does not constitute a non-compliance thereunder. Based on the form of confirmation letter and designation letter we reviewed in Appendix D, the risks are remote for the Company to be found obligated to return funds to the customers or their designated third-party payers, their respective banks and/or liquidators under the Third-party Payment Arrangement.
- 54. Based on the sample designation letter reviewed by us (set out in Appendix C hereto), we are of the opinion that:



- a. in any event, including but not limited to where there is (i) any dispute or disagreement among the customers, the third-party payors and/or the Company concerning the relevant sales agreements between the customers and the Company or the designation letters, or (ii) any failure by the customers or by the third-party payors on behalf of the customers to settle the payments concerning such sales agreements, or (iii) any request by the third-party payors for refund of the payments made or settled on behalf of the customers concerning such sales agreements, the customers shall remain primarily liable for the payments concerning such sales agreements and all other liabilities arising out of such sales agreements;
- b. the customers have undertaken to fully indemnify and hold harmless the Company against all losses, payments, costs, expenses, liabilities and damages which the Company may suffer or incur arising out of or in connection with any failure (including any disputes or disagreement) by the third-party payors to settle the payments concerning such sales agreements on behalf of the customers or any breach or failure (including any disputes or disagreement) by the customers and/or third-party payors to perform their obligations;
- c. the designation letter constitutes legal, valid, binding and enforceable obligations of all of the parties thereto, including the Company, the customers and the third-party payors; and
- d. the Company shall have an enforceable right to claim (i) indemnity from the customers; and/or (ii) compensation against the customers and the third-party payors if any of the customers or third-party payors breaches or fails to perform its obligations.
